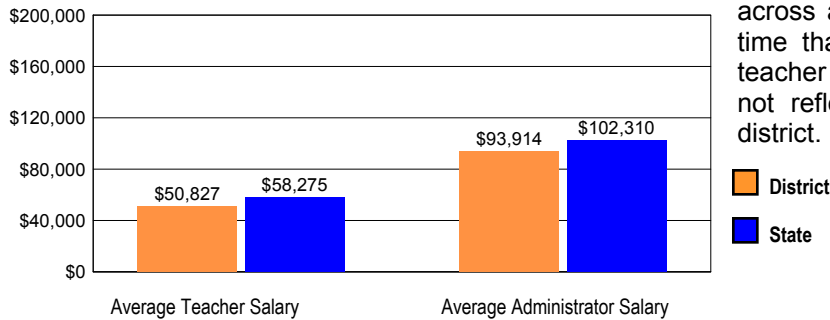

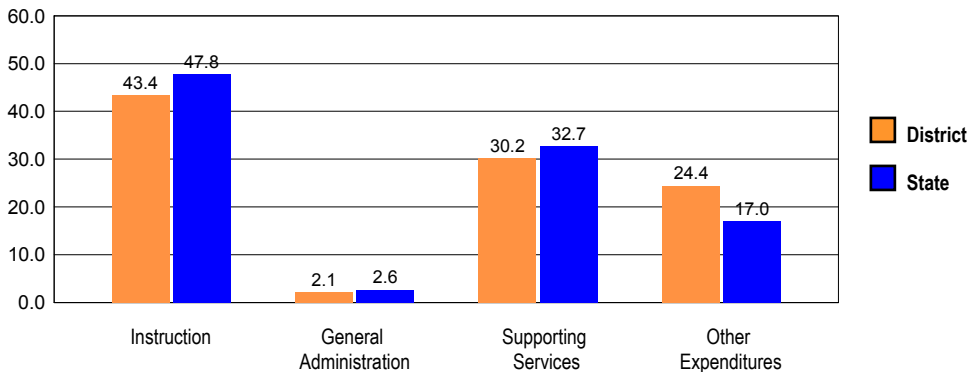
SCHOOL DISTRICT FINANCES

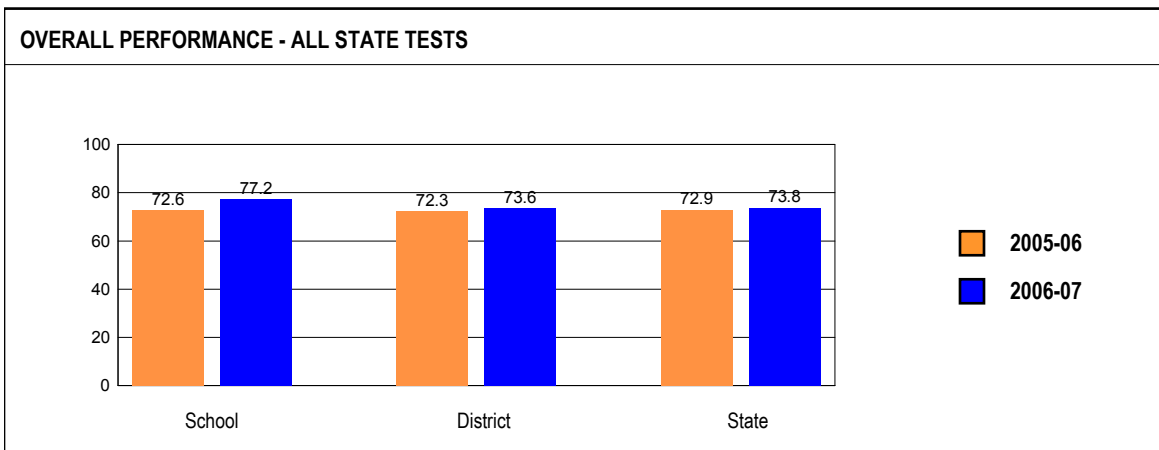

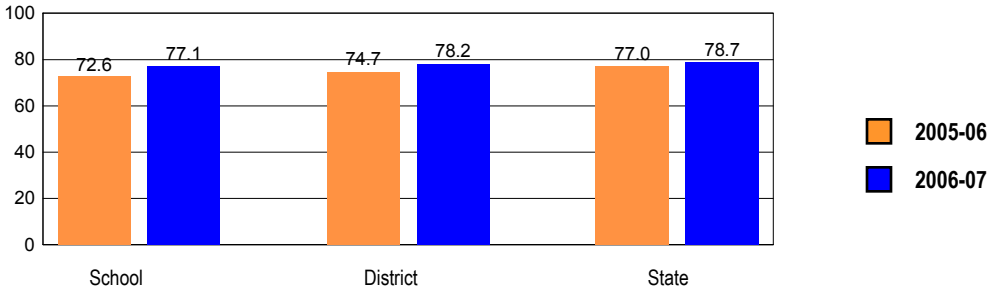

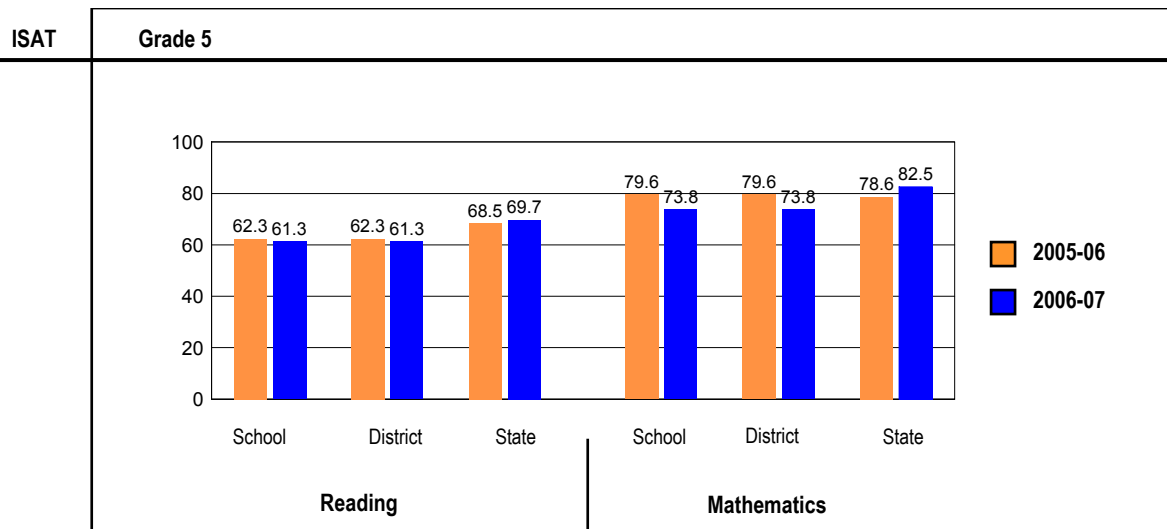
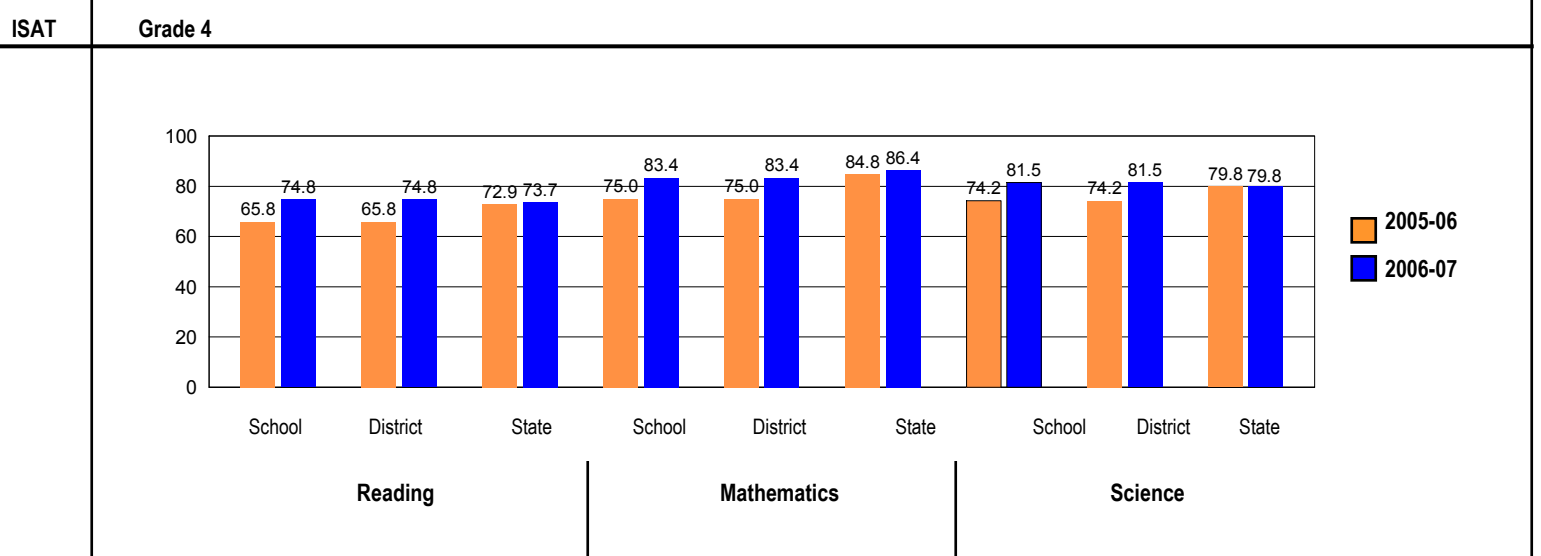
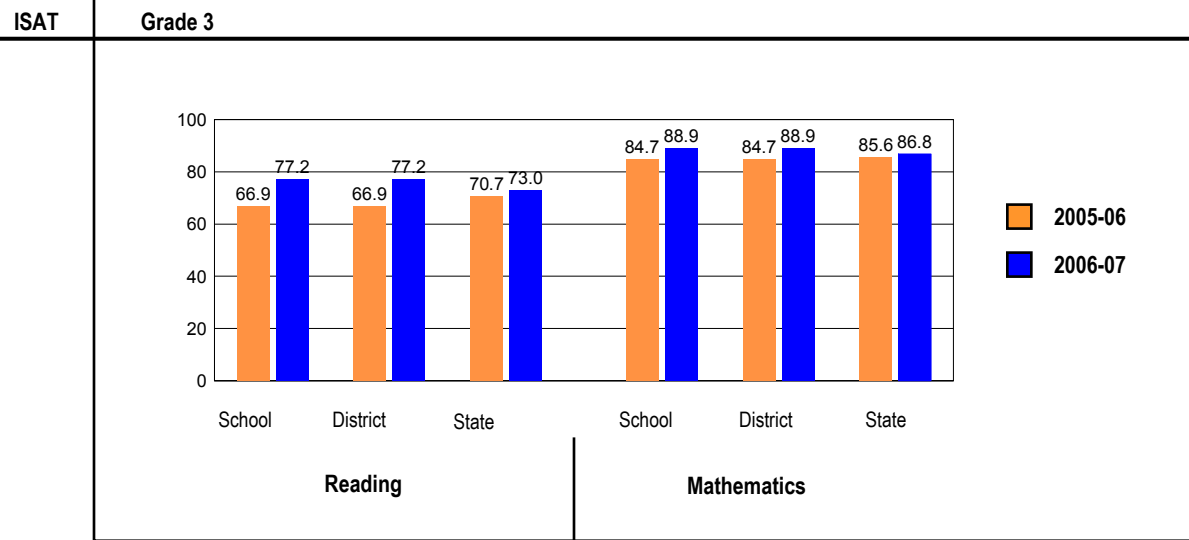


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Measure of Annual Growth in English (IMAGE) is administered to limited-English-proficient students. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

PLANNED IMPROVEMENT FOR THE SCHOOL AND DISTRICT

The faculty, staff, and administration of Herrin Elementary School are dedicated to providing students with high quality, well-rounded educational experience. Our first priority is to promote academic excellence in an environment that also meets the social and emotional needs of our children. With the goal of meeting the high standards we have set for our school and our students, evaluation of curriculum, instruction, programs, and procedures is an ongoing process.

An important part of the evaluation process is identifying strengths and areas in which improvement is necessary. Herrin Elementary School uses many methods and tools to assist in this process.

Herrin Elementary School participates in the state-wide ISAT testing each spring. These tests assess student mastery in reading and math at grades 3-5 as well as writing at 5th grade and science at 4th grade. These tests produce data that allows us to compare our student achievement with other schools throughout the state as well as monitor progress within the district from year to year. Individual student scores from the ISAT are reviewed annually. These individual scores allow teachers to target specific students in their preparation and instruction in an effort to reach higher levels of student learning and mastery.

The ISAT scores are also analyzed for student mastery by content area. Achievement is monitored by grade level and weaknesses or "gaps" are identified and targeted for improvement through curriculum and/or instructional modifications.

Also, this year, Herrin Elementary School is piloting a new math program with one teacher at each grade level using new curriculum guides, texts, resources, etc. The pilot process will be monitored closely within the district through committees and assessment results to compare the new program with the current math series.

Finally, in the spring of 2007, for the first time at Herrin Elementary School, each 2nd grade student was evaluated using the ISEL reading instrument. Results are used to identify strengths and weaknesses of individual students for intervention targeted instruction. This evaluation is an ongoing process throughout the year to monitor student progress and mastery in reading.

Title II Class Size Reduction funds have been used to provide a seventh section in both Grades 2 and 3 to keep enrollments at 21 and 24 pupils in each class, respectively, instead of 6 sections of 25 and 28.
